Do you know Code 302.4 ?

All lots and parcels of land must be maintained under **12**" and free of any diseased trees or plants. (sec. 23-70) You can be fined for tall grass in front or back yard! Code Violations can be called into the City at Neighborhood Moving 361-880-3030
